

CPRA PRIVACY INFORMATION REQUEST FORM



Under the California Privacy Rights Act (CPRA), residents of the State of California have, subject to exceptions, the right to know about the personal information that Cupertino Electric, Inc. (the Company) collects about them, to correct inaccurate personal information about them, to delete personal information obtained from them, and, where applicable, to opt-out of the sale or sharing (i.e., disclosure for cross-context behavioral advertising) of their personal information (CPRA Rights). The CEI's California Privacy Policy explains that CEI does not, and will not, sell or share personal information and provides a detailed explanation of the right to know, the right to correct, and the right to delete. California residents who wish to submit a request to exercise one of the CPRA Rights can complete the following form to allow CEI to verify the requestor and to respond to the request.
